# GIETZELT ANNOUNCES VETERANS' ENTITLEMENTS ACT MONITORING COMMITTEE

The Minister for Veterans' Affairs, Senator Arthur Gietzelt, has announced the establishment of the Veterans' Entitlements Act Monitoring Committee.

The Committee will report to the Government within a year on the operation of the Veterans' Entitlements Act (VEA), which came into effect on 22 May 1986.

The independent chairman of the committee is
The Hon. Paul B. Toose, a former judge of the Supreme Court of
New South Wales, who has had extensive experience in veterans'
affairs matters and who is held in high regard by the ex-service
community.

Senator Gietzelt said that while Parliament was considering the VRA last year, he gave an undertaking that he would establish a committee to report on the first twelve months of operation of the Act. As he had indicated then, the committee membership includes representatives of the ex-service community.

He said the committee will begin work promptly, with administrative support from the Department of Veterans' Affairs.

I am writing to express my appreciation of your agreeing to be a member of the monitoring committee to report on the first twelve months' operation of the Veterans' Entitlements Act.

I propose to make a formal announcement shortly of the membership and terms of reference of the committee as agreed by Justice Toose.

Attached is a list of members of the committee. Justice Toose has agreed to chair the committee.

The terms of reference of the committee will be as follows:

"Having regard to:-

- (a) the stated objectives of the Government in the passage of the Veterans' Entitlements Act (as amended) and the Veterans' Entitlements (Transitional Provisions and Consequential Amendments) Act (as amended), as outlined in the explanatory material provided to the Parliament; and
- (b) the operational experience of that legislation;

the Committee shall meet to discuss the effectiveness and efficiency of the legislation as outlined in (a) above and shall report as soon as practicable to the Minister for Veterans' Affairs on those aspects and on the extent to which the Government's objectives are being met by the legislation.

The Committee shall commence its deliberations one year after the proclamation of the VEA and report to the Minister within the succeeding year."

An officer of my Department's Sydney office will be providing administrative and secretarial support to the committee. That officer will assist in the co-ordination and presentation of material to the committee for its consideration.

The committee will meet in Sydney using facilities available at my Department's office in the Grace Building at 77 York Street, Sydney. It is envisaged that the committee will meet monthly and the first meeting has been set down for Friday, 22

A copy of your report to the Annual General Meeting of the Australian Veterans and Defence Services Council has been brought to my attention. There are the number of issues discussed in your report which I believe could give a false impression of the Veterans' Affairs portfolio. I have, therefore, taken this opportunity to respond and would be grateful if my response could be given similar publicity to your report.

# Repatriation Determining System

Your report expressed concern regarding the backlog at the second level of the Repatriation Determining System, the Veterans' Review Board.

Firstly, I should point out that considerable improvements have been made at the first level of the determining system. Most of the backlog at that level has now been brought under control. Moreover, most Veterans' claims are finalised at the first level. Only 30% of those decisions are appealed to the Veterans' Review Board.

Your comments regarding the backlog at the Veterans' Review Board level are simplistic. The build up of cases at the Veterans' Review Board level is to a large extent a consequence of the recent huge increase in decisions at the primary level. That backlog at the first level is now passing to the second level. That is inevitable. The delays now existing at the Veterans' Review Board level will in turn be brought under control also.

The Principal Member of the Veterans' Review Board is looking at ways to improve the efficiency of the Veterans' Review Board. A number of measures have already been taken and the recent management review of the Board's activities has suggested a number of ways to further improve efficiency. I have set up an Implementation Task Force headed jointly by the Deputy President of the Repatriation Commission and the Principal Registrar of the Veterans' Review Board to assess and implement the recommendations of the management review.

I should also point out that of the 20,000 or so applications for review now before the Veterans' Review Board only 43% have in fact filed a certificate of readiness for hearing. Of those cases approximately half will be adjourned, withdrawn or postponed after the matter is listed. This occurs appeal framework by the Veteran, the instances when a Veteran might lose a TPI pension would be limited to those where fraud or misrepresentation was involved.

Contrary to your assertion, I am not aware of any decision given by a court in which it has been said that there could be a review of a TPI pension some years after its grant. TPI pensioners have no cause for concern that their TPI pensions there has been fraud or misrepresentation. Accordingly, I stand affect existing TPI pensions.

# Australian War Memorial

As to your concern whether the Government's decision regarding the dismissal of the Director of the Australian War Memorial was justified, you will now have seen my statement to the Parliament on the matter. I suggest you should draw that to your members' attention.

I repeat that there is no threat to the independence of the AWM. I have no legal power to control the AWM's affairs. The AWM Council continues to control the affairs of the AWM. The control the policies of the AWM.

# VEA Monitoring Committee

As regards the establishment of a committee to report on the first 12 months of the Veterans' Entitlement Act's operation, I expect this committee to be established in the near future. I suggest any assessment of the impact of the VEA should await its

Finally, let me again assure your members of the Government's commitment to the Veteran community. There has been a 40% increase in expenditure on the Veterans Portfolio during this Government's period in office. Major improvements have been made to the Repatriation Determining System. The Veterans' Entitlement Act is now in place. New Home Care and Joint Venture programs have been developed. Plans to upgrade the Repatriation Committed to meeting the needs of the Veteran community and stands on its record.

- b) Effect on many totally disabled veterans and their (potential) widows;

  - d) Effect of G.A.R.P. and the Lifestyle Questionnaire
  - e) Varying results between States
  - f) Possible use of Sect.31 by the Commission
  - g) There will certainly be other matters submitted.

I have had calls from and made calls to states since the receipt of this letter. Victorian and Tasmanian branches had not received a copy so I include a copy for them.

I rather feel that not all the information has been given to Bob Whyburn. We are all aware that we were under pressure to vacate Legacy House on Sunday 3 May but my understanding is as follows; Vice President.

There were several motions put forward to expand the size of the National Office. Finally it was agreed that the position of National Vice President be formally included as an executive decision rather than an appointed decision.

Hence Kevin Gill was appointed by a majority decision.

Secretary and Treasurer.

All nominees for these positions withdrew their nominations prior to voting and no further parties wished to nominate or accept nomination. Accordingly it was felt that Tim McCombe was the best man for these positions and it was left to the National President to liase with Tim in the hope that he would reconsider his decision and agree to return to the positions of secretary and treasurer. I was given one month to resolve this decision.

National solicitor and auditor.

These appointments were left pending the resolution of the secretary and treasurer positions.

It is my belief that all decisions made and actions taken were agreed to by all states delegates and presidents, the members of the National Council. To call for a resumption of the National Congress or a Special General Meeting will involve additional costs which the Association can ill afford and may not lead to any great changes.

This office of President exists to action the decisions of the states, not to make decisions without consultation with the states.

THEREFORE THE DECISION TO RECONVENE THE NATIONAL CONGRESS LIES WITH THE STATES AND I ASK ALL OF YOU THAT YOU DISCUSS THIS MATTER WITH YOUR STATE EXECUTIVES AND ADVISE YOUR REQUIREMENTS AS SOON AS POSSIBLE BUT NO LATER THAN 7TH JUNE.

AGAIN ALL STATES MUST BE BOUND BY THE MAJORITY DECISION AS IS OUR PRACTICE.

Thank you for your letter of 19 May 1987 which brought to my attention three resolutions passed at the 8th National Congress of the Vietnam Veterans Association of Australia.

The first of your resolutions concerned Defence Force Retirement Benefits. This is a matter outside my portfolio responsibilities and I have forwarded a copy of your letter to the Minister for Defence.

Your second resolution concerned Financial Institutions Duty. As I understand it, all State Governments except Queensland have introduced a charge referred to as Financial Institutions Duty. In Tasmania, the duty applies to withdrawals from accounts while in the other States, it applies to deposits. The charge itself is levied against the financial institutions but they then pass that charge on to their customers.

As a result of my representations, the State Governments of New South Wales, Victoria, South Australia and Western Australia introduced amendments to their legislation which, from 18 April 1985, provided an exemption from the duty for Repatriation pensions which were direct deposited into a pensioner's account. The exemption does not apply to those pensioners who are paid by cheque and subsequently deposit that cheque into an account with a financial institution. In the case of Tasmanian residents, the exemption from the duty imposed in that State applies only to holders of a Pensioner Health Benefits card or its equivalent.

If any of your members believe they are being incorrectly charged duty on their pension payments, they should discuss the matter with the manager of their bank, building society or credit union.

Your third resolution was about the recovery of treatment costs for privately insured patients. The new arrangements enabling beneficiaries to use their health insurance when treated at either a Repatriation General Hospital or a public or private hospital were brought into place to assist the Department in ensuring resources are used in the most effective way possible.

There is absolutely no risk to health insurance entitlement of either the individual veteran or his family. The arrangement operates only in respect of the basic table. Basic table benefits are available 365 days a year and cannot be reduced by being drawn upon in the way higher table benefits are.

The decision to use private health insurance in lieu of Repatriation entitlement is entirely voluntary. I would ask, however, that in making the decison, your members consider the potential benefits. By reducing hospital costs, my Department is better able to use its resources to enhance existing programs and develop initiatives which will improve services.

# MY CONTRIBUTION TO THE ASSOCIATION: 4

My background within the Association is:-

I have been with the Federal Executive since late 1981. My contributions have been:

- 1) Organising the mariginal seat meetings which extracted a promise from the now Prime Minister, a Royal Commission would investigate the problems of Vietnam Veterans.
- Involved in the research on the 30,000 Army files files pertaining to Vietnam, which are held at the War Memorial in Canberra. Many of the documents extracted from these files were presented as evidence to the Royal Commission.
- Mainly responsible for raising of over \$30,000 for the Royal Commission Trust Fund. This was achieved through a concert at the Entertainment Centre in Sydney, plus the sending of letters to Trade Unions, R.S.L. Sub-Branches and to Companies.
- Involved with the late Phill Thompson negotiations with the Minister for Veterans' Affairs, which resulted in changes to the Repatriation Act that made the National Advisory Committee for the Counselling Service independant from the Department of Veterans' Affairs, and moved that responsibility to the Minister himself.
- Travelled to the United States during the Royal Commission. Liaised with, and made arrangements for scientific witnesses to travel and appear before the Royal Commission.
- 6) Attended most of the hearings of the Royal Commission.
- 7) Researched the Agent Orange issue continuously since 1981, acquiring a very good knowledge of the issue.
- 8) Researched the comprehensive critique of the Royal Commission Report which was submitted to the Government on the 8th April, 1984 for their appraisal.
- 9) Researched and compiled the second critique of the Royal Commission Report which was submitted to the Government on the 20th March, 1987.
- 10) Held negotations with the Government in regard to the appointment of Bob Hogg as a special consultant to the Minister of Veterans' Affairs

with regard to the Agent Orange Royal

Commission.

- Have been the Associations' Representative to the Australian Veterans and Defence Services Council for four years, attending meetings on the first Monday of every month.
- 12) Have accepted the position of Assistant Secretary to the Australian Veterans and Defence Services Council.
- 13) At the request of the Minister for Veterans' Affairs, I accepted an appointment to the V.V.C.S. National Advisory Committee.
- Over the years there has been a network of lawyers, which are willing to give legal advise to me on a voluntary basis; Bob Wyburn (solicitor), Alan Hill (Barrister), Adrian McInnes (Queens Council), Chris Enwright (Senior Lecturer of Admin Law, Macquarie Uni), Steve Crawshaw (Barrister), Max Kimber (Barrister)
- Also, over the years, there has been a network set up with scientists, here and overseas who are willing to advise me; Dr. John Pollock (Aust), Dr. George Humphries (Aust.), John Evans (Aust), Dr. Alister Hay (Eng.), Dr Elen Silbergeld (U.S.A), Dr. Deborah Barrsotti (U.S. A.), Dr. Ruth Shearer (U.S.A.), Dr. Sneiderman (U.S.A.), Prof. Alan Ascleson (Sweden), prof. Tennant Hardell (Sweden).

  I have met the above scientists and have been communicating with them on a first name basis before and after the findings of the Royal Commission.
- 16) Manned the various offices at the Association on a voluntary basis.

# DEBRIEF:

If elected as President, and with the approval of the State President, priority will be given to the resurrection of the Association's magazine on a monthly or bi-monthly basis, making sure that strict conditions will be placed on the publisher in regard to advertising in the Journal.

Grame Walker, Jock McCulloch (author of Politics of Agent Orange; Asbestos, It's Human Costs), Greg Lockhart (Ex Capt., Vietnam Veteran, Unit of Pacific Studies AMU Uni.) are

willing to conribute articles to the Journal.

### FINANCE:

John Schumann (Ex. Red Gum) has agreed to help with organising a concert similiar to the one held at the Entertainment Centre. John advises me that it is a matter of timing if the Association is to recieve maximum benifit from the concert.

The previous Publisher of Debrief was paying the Association \$500 an issue for the editorial from this association. If the Journal is published monthly the income would amount to \$6,000 per year.

### MANNING OF THE OFFICE:

If elected President, I would be able to man the office at Randwick between twenty and thirty hours a week. Of course this would be subject to other committments I would have for the Association.
