The congress was recessed until 9am sunday 7th May 1989.

The WA State branch entertained delegates and members at a "Sixties Night" at a Perth hotel.Great night.

President Tim re-convened the 10th National congress

1. MINUTES OF THE 9TH NATIONAL CONGRESS

Moved; QLD Seconded; TAS
That the minutes as circulated are a true and correct record of
the 9th National congress and that they be received

2. BUSINESS ARIZING

- 2.1 QLD queried the date of submission, to the Minister of Veterans affairs of the items pertaining to veteran welfare. President Tim accepted that he was at fault in the late submission and apologised for the oversight.
- 2.2 QLD noted that the item from the previous minutes tended by the QLD state branch (Motion no 2, 9th Nat Congress) was also tended to the Minister and that a "Less than acceptable" reply was returned.
- 2.3 QLD stated its disappointment in the other states that they had not promoted the sale of VVAA Plaques (Motion QLD no 9th National congress) and that it was a worthwhile exercise and announced the amount of \$143 presentation to National office.

 QLD expressed the view that all states should promote the sale of the Plaques and the suggestion that an advertisement should be placed in 'DEBRIEF'
- 2.4 The following items were deferred to general business
 - (a) Medals, HMAS SYDNEY and logistical support forces
 - (b) Citations, Members served 173rd Airborne Bde

3. TREASURERS REPORT

- 3.1 National Treasurer Mr Grant Collins tabled his report that had been circulated which included

- 3.2 The Treasurer commented on the following items
 - (a) That payments to the total of \$2400 in cheque form from the publishers of "DEBRIEF" had NOT been honored on two occasions, this in default of contract. Having left it to National President Tim to contact the publishers, and not being satisfied with the results he contacted the publishers and became aware of problems re the National mailing list.

The Treasurers stated it was very important that congress discussed the problem and gave some direction to the National executive on this matter

- (b) The Treasurer outlined his misgivings on the travel costs of VVAA advocates and asked that congress give direction on this problem
- 3.3 The National treasurer gave a report on the current financial situation since the end of the last audit period (31 Dec 88)

It was resolved that from previous experience this was not an exercise that would be successful, as was shown during the Royal commission and since.

10.6 REPATRIATION GENERAL HOSPITALS

Moved : WA

Seconded : NT

That the WA branch of the VVAA agrees in principal with the handing over of RGHs to the state hospital system, that this process could be stopped for the present, But points out the dangers of not reaching a negotiated settlement within the near future.

Within a period of 10 years the returned service community will be reduced from an estimated 680,000 to 360,000. It would be apparent what this will do with our lobbying power and thus our negotiating strength.

Governments of any complexion will dictate rather than negotiate with the ex-service community. We therefore recommend to the

congress that the VVAA agrees to transfer of RGHs on the following conditions

- a. That no person eligible for treatment will be disadvantaged with regard to access for quality of treatment
- b. That the staff of RGHs not be disadvantaged with regard to pay and benefits
- c. That the transfer shall not take place until such time as suitably enforceable contracts have been signed between the commonwealth and the states
- d. To assist in the oversight of the operation of these contracts and the welfare of beneficiaries, this branch of the VVAA recommends an addition to the conditions, Presently under consideration, this being the appointment of two (2) Ex-service representatives to the health commission of each state and two (2) Ex-service representatives to the board of each hospital

After wide discussion it was resolved with the following motion

That due to lack of direction to Delegates from their membership it was moved that the above motion be dealt with at National council in Alice Springs, after direction from membership CARRIED

We are happy that other support groups and the South Vietnamese

population in Australia have indicated they may do so. CARRIED

It was resolved that the National secretary point out to Senator Ray (Minister for Immigration) that as per the Presidents statement that the submission re Austasian children has not been ratified by National congress and that it is revoked.

The following points of discussion were put forward from all quarters of the meeting and are listed with repetitions taken out

- c. Criticism of RSL is not deserving in all states
- d. That change in the RSL can only come from within
- e. Public perception is that.. RSL and VVAA is in conflict

- f. Any disagreement between RSL and VVA should be direct not thru media or DEBRIEF
- g. That care taken to ensure that letters to the editor in DEBRIEF is not stirred up.
- h. That there is both non support and support amongst Vietnam veterans for the RSL
- i. That although the RSL is permitted its views the VVAA should assert its views without confrontation and the VVAA will be seen in a more professional view
- k. Lack of unity should not be supplied as a weapon to governments
- 1. Better communication should be developed

The VVAA look into the loss of War Widow's rights under new DSH Loans Scheme since the hand over to Westpac

MOTION 2

PORTABILITY OF DSH LOANS

The VVAA lobby the Federal Government to keep election promises made before the last election in making ALL DSH loans portable including pre-Dec 1987.

VIETNAM VETERANS JOBLINK SCHEME MOTION

Speech for George Gear, MHR.

Tenth Annual VVAA National Congress, WA.

May 6, 1989.

(Introduction as required)

Thank you for allowing me to represent my colleague, the Minister for Veterans', Ben Humphreys, at your national congress.

He made a point of asking me to give you his apologies at not being here, and also that I pass on his best wishes for a successful function.

It is something of an honour to address this tenth national congress: a decade of well-attended function is always a satisfying achievement, and it shows just how far the VVAA has come since it was formed.

Although the Association was born basically out of frustration and concern over some narrow issues, it has grown and matured into an organisation to be respected.

The Federal Government regularly seeks the VVAA's advice - if the association hasn't already lobbied the Government first - and values the time and effort the Association puts into its various representations.

I welcome the chance to see the Association in action today. I'll listen very closely to the discussions, because I believe one of the great benefits of these congresses is the chance to assess the weight of opinion.

My political experience has shown you often get a patchwork of opinions on most subjects. These opinions are generally sincere, but they can also be very different. Gauging which opinion represents a majority view is sometimes extremely hard.

And sometimes, when there isn't a majority view held, it's just as difficult to know which opinion is the right one to believe in.

But in each of these cases, rational discussion and consultation are the keynotes if there's to be any chance of success. Your agenda includes some fairly contentious issues and I expect these will be well covered over the congress. I look forward to reading the outcome of the debates.

Later this morning, there'll be an address by someone I'm sure you all know, Mr Ric Marshall, the Director of the Vietnam Veterans' Counselling Service. Among other things, he'll be giving you an update on the latest developments in the country outreach project.

You'll also be addressed by someone many of you won't be familiar with, and that's the new Secretary of the Department of Veterans' Affairs, Mr Lionel Woodward.

I say "new" only as a relative term: Lionel's been at the helm since late February, and he's put a lot of time and effort into coming to grips with the Department's enormous responsibilities.

An important way he's doing this is by compressing the years of knowledge accumulated in the ex-service community into readilyassimilated material through coming to functions such as this.

A few hours spent here - dare I say at front line of it all - is worth infintely more than days of briefings and reems of reports in a Canberra office.

Reports and briefings are necessary tools of any bureacracy - especially in one as big as the DVA, but although they are valuable, they cannot impart that special flavour - that indefinable factor - which sets each group apart from its peers.

Only by being here - by listening, absorbing and remembering - can one hope to come to grips with the unique nature of the group.

Of course, you in the VVAA see your group as being crucial to protecting the interests of your members. And although I know the Association is taken very seriously by the Department, you must remember that it is really just one of many such groups with which the Department - and the Secretary - deals on a daily basis.

There are thirty such major groups known to the Department - that is, groups with a national executive body and branches in at least four states. This collection includues bosdies such as Legacy, the

Limbless Soldiers' Association, and the Royal Australian Air Force Women's Associataion.

These 'umbrella' groups have a common core of concerns for their members, but also can have unique demands and requests.

The success of each group's approaches to Government with their concerns depends on how well its case is stated, which in turn depends on how well it has been prepared.

Mass meetings of members - such as the assembly here today - can play an important part in framing cases and forming approaches.

The Department of Veterans' Affairs is one Department which I believe is extremely receptive to well-thought out submissions: the evidence of this can be measured by success.

You'd all be aware that the Government agreed to build a memorial to Vietnam veterans in ANZAC Parade, in Canberra. What you may not know is that the Government will give \$200,000 towards the memorial's cost, on top of allocating a site.

I'm sure most Vietnam veterans will applaud this decision, which is a good example of what concerned groups can achieve.

But it is not the only one. Look at the progress on the country outreach project, the crisis telephone line, and the emergency accomodation.

Lionel Woodward and Ric Marshall will tell you more about these later, but I wanted to mention them as exemplifying the process of Government/ex-service group consultation.

National meetings are always great for meeting old mates, and catching up with people you've not seen for a while, but this is not whye they're held.

The results of this congress - whatever they are - could have an impact on a lot of people, for a long while to come. It is not only an important function for you as VVAA members, but will also mould opinion in the general community about the VVAA.

So, in closing, I wish you well in your deliberations, and trust the decisions you arrive at will be able to be carried forward for the benefit of all veterans and thier families.

Address by Ric Marshall 10th National Congress VVAA Perth 6 May 1989

Mr President, Mr Gear, Mr Woodward, Distinguished Guests, Delegates

Thank you for your invitation to your congress and for asking me to speak to you again on the work of the Vietnam Veterans Counselling Service.

Delegates have heard from me as National Director of the VVCS at previous National Congresses and today you have already heard Mr Gear mention on behalf of the Minister for Veterans Affairs some of the things being done by the Government through the VVCS.

My new boss Lionel Woodward, has also provided you with the benefit of his first impressions in the role of Secretary of the Department of Veterans Affairs and I find it most encouraging that, in spite of all the horrifying stories of how tough the VVAA is to deal with and how inclined it is to cross swords with the Department, he has come to this congress to find out for himself what the VVAA is on about. I also have found it most encouraging to observe how quickly he has gone about confronting the fears about the future of the Department and providing the reassurances that are necessary in this climate about the future of the Department and the continuity of special services for veterans and their families.

I have now been National Director of the VVCS for 4 years after working as it were "up close" to veterans and their families with problems of one sort or another and being National Director has given me a chance to stand back a little while helping to keep the Service maintained and supplied. Counselling veterans and their families has always been in my experience an privilege. As you probably know, I was not in SVN - I was rejected for National Service on medical grounds - a skin disorder. It is somewhat ironical and really brings home to me now how lucky I was when I now find that many of the clients I deal with suffer worse skin complaints than I ever did! And other problems as well.

I guess that what I am talking about is that there is clearly a cost to war service, and an obligation on those of us in the community who didn't have to serve in Vietnam to care about and care for those who did in the same way as veterans care about their mates. We also owe continuing of gratitude and respect. As John Parsons - a director of the American Vet Centre project says - "you can never say thanks often enough".

So from me to you who went on my behalf and those you represent - THANK YOU - IT'S A PRIVILEGE TO BE WORKING WITH YOU.

Now on to the VVCS

As we all know the VVCS was set up "to help veterans and their families with their health and social problems". It was set up specially for Vietnam veterans but we have never turned any veteran away. What are the needs?

As I see them - and it's often good to reconsider what the job is so that we can see how we are going - to do the job we have got to provide:-

- an <u>approachable</u> service that the veteran knows they can rely on. People need to be wanted/valued - not be treated like a nuisance.
- a service that meets veterans and their families at their point of need - that includes a willingness to do the simple practical things to allow the person come to grips with the underlying problem - forms, phone calls, roof overhead.
- a service that deals with first things first defuses immediate sore points - provides a space to get the heat out of the situation - deals with the <u>now</u> crisis and THEN
- counselling to help adjust to relationships, anxiety-stress issues, anger, self esteem/efficacy, and perhaps uncover and allay some of the old hurts or horrors.
- a recognition of what else might help and encouragement and assistance to get it.

So what are we doing

 continuing to provide high quality (or so our clients tell us) counselling from centres

country outreach

- have trained Area Representatives at .Gold Coast, .Port Macquarie, .MacKay/Cairns/MtIsa,
 - .Bendigo/SwanHill/Mildura..
- are preparing for training for
 - .AliceSprings/Gove/TennantCreek, .NWTasmania,
 - .Wagga/SouthCoastNSW, .Gippsland, .Goldfields/SW-WA ...

Encouraging to hear from Frank Hunt who has been carrying this sort of work almost single handed in his area for nearly 15 years that he is now getting a sense of "the weight lifting off his shoulders". Well, I suppose its about time!

008 Services both to Centres and after hours

- we have the long standing Adelaide arrangement that Grant pioneered
- Aug Oct 88 Sydney training 008 opened Nov 88 -NSW/ACT pilot - dealt with 50 calls per month - 5 being severe crises
- extending to SQ, NQ, NT, Country SA, VIC, TAS, ACT, WA. Implementing 008 line, redial, beepers.
- . The backup from Salvo Line & Crisis Care in particular has been fantastic.

The Veterans Emergency Accommodation Grants Scheme

- Angus House is now a proven fact a pilot that has truly been worthy of the name full credit to Jim Muir who conceived it John Thompson who adopted it at birth and Ray DeVere who provided the discipline it needed at adolescence. And now full credit to the RSL for coming in like grandparents often do and providing for a permanent home. Truly a remarkable team effort.
- As mentioned earlier, the Government has now provided \$400,000 to get others going.
- the VEAGS Steering Committee has had 2 meetings
 - grants recommended in WA,NT and now SA
 - proposals are being considered from ACT
 - potential proposals being developed in NSW and Vic
 - . Tas considering now bush retreat is underway

Veterans Own Initiatives

They are worth listing - a record of impressive achievements - for a group that 10 years ago didn't even have their own association and were not a strong part of any others:-

Just a few things that come to mind:-

district barbecues, the Royal Commission, Vetfit, Sports Teams, Welcome Home Parades and Reunions, Joblink, National Memorial, Published Books, Small Business Advisory Group, Legal Advisory Service, Advocacy, VV Family Support Link Line, VV Council, Austasian children initiatives, Keith Payne Hostel, VV Trust, Special Regimental Events - Long Tan, Coral, Vietnamese/VV joint activities, Bush Retreat, Farm Placements, Research Projects including the recently published Field and Kerr Study, SA Veterans Crisis Line, and not forgetting that the VVCS itself was a Vietnam veterans initiative...

The list goes on and bears no resemblance whatsoever to the mad Rambo time bomb, or angry demanding emotional cripple image so often bandied around. It in fact demonstrates a group of competent, effective and successful people with strong bonds - still caring for one another and contributing in an exemplary way to the community around them and to the Nation they served.

There's more to be done but a lot has been achieved. Congratulations!

There are also the excellent <u>personal</u> contributions of individuals in the VVAA and other veteran organisations. Everyone here is here because of such contributions but I would like especially to compliment your President, Tim McCombe. Tim is a member of the National Advisory Committee on the VVCS where he contributes energetically and constructively to discussions on how the VVCS should operate. He is also a highly respected advocate, lobbyer and spokesman for veterans and their families. Thanks Tim.

The VVCS has been proud and privileged to be part of the things I have been speaking about and we look forward to serving veterans and their families in these ways as a special part of the Veterans Affairs Portfolio for as long as it is needed.

PRESIDENT'S REPORT MAY 1939

Since the formation of the Vietnam Veteran's Association ten years ago there have been major gains achieved for the Vietnam Veterans by this Association. Some of these achievements are:-

- Alerted the government to the unhappy plight of so many of our Vietnam Veterans.
- . Convinced the government of the day, of the need for the formation of the Vietnam Veteran's Counselling Services.
- . Made representations which convinced the Parliament to pass an amendment to the Repatriation Act in order to upgrade the repatriation entitlements of Vietnam Veterans to the same levels as those of WWII veterans.
- . Convinced the government of the need for a Royal Commission into the matter of toxic chemicals.
- . Identified the need for Half way houses for veterans in crisis and initiated the establishment of Angus House in Brisbane.

Have had some success with sponsoring cancer claims in the repatriation system, based on exposure to chemicals.

More recently, when the Government accepted the recommendations of the Evatt and Hogg reports, we have achieved:-

- An increase of the Vietnam Veteran's Counselling Service staff,
 by six, and an extension of the services, by providing one
- thousand hours a year of counselling in country areas.
- Four hundred thousand dollars allotted by the Government, for the establishment of Half Way Houses/Hostels in capital cities, for veterans in crisis.
- . A donation of two hundred thousand dollars towards the Vietnam Veterans' War Memorial to be built in Canberra.
- Declaration of a Vietnam Veterans Day on the Anniversary of the Battle of Long Tan (18 August).

Another major achievement was when the House of Representatives

Standing Committee on Community Affairs tabled it's report titled

"After the March". It is pleasing that many of our submissions are included in that report. It is an excellent report. Amongst its report recommendations are:-

Guaranteed independence of the Counselling Service by making it a Statutory Authority.

- . The extension of the Counselling Service into country areas to get underway without delay.
- Examine the possibility of free-of-charge, 24 hour-a-day, crisis telephone counselling services, in all states.
- Greater government assistance for the establishment of half way houses like ANGUS HOUSE, in all states.
- . Government support for programmes modelled on the Western Australia "Job Link".
- . Government employment preference for Vietnam Veterans.
- A research officer to work with the Counselling Service, to keep up with the latest toxic chemical studies.
- . More staff.

It is interesting to note that the Minister has yet to reply to the recommendation of the report, six months after the report has been tabled, despite: a three months statutory obligation to report to parliament.

THE CHEMICAL ISSUE

We have a number of cases before the Administrative Appeals Tribunal, in Victoria, (one case) and in NSW (two cases), relating to exposure to toxic chemicals. I hope these cases will be finalised before the end of this year. The Victorian case was due to be heard by the Tribunal on the 10th and 11th April, but due to the unavailability of the barrister it had to be adjourned.

I have now become involved as an advocate to the Veterans' Review Board specialising in cancer cases. I have had two cases heard before the Board (one was a joint preparation with Legacy) and I am still awaiting the decisions. I have a case listed for hearing and another six cases awaiting specialist reports.

There have been a number of developments in the area of studies concerning child abnormalities in the children of Vietnam Veterans. The Kerr/Field Study on children of Tasmanian Veterans and the change of mind by the scientist conducting the "Ranch Hand" studies are of major consequences.

THE NATIONAL OFFICE

Since the advertisement in "Debrief" for voluntary workers, I have now, five part-time workers assisting in the office. The backlog of filing has been reduced to a minimum. It will now be possible to resume, on a regular monthly basis, an information backage to be sent to the states.

During the past year, in my capacity as the National President, I have made twenty one trips to Canberra, three trips to Melbourne, three trips to Wyong and one trip to Wollongong. A total of twenty-eight trips. (Extracted from the diary).

The finances of the National Office are in a healthy state. Notwithstanding this, the office is operating without a photostat machine, typewriter and typist. The typing for the office is done by voluntary workers outside the office.

WAR VETERANS RALLY

I was approached by a group of RSL sub-branches to help organize a meeting of war veterans at the Sydney Town Hall. The purpose of the meeting was to voice their concerns on the reduction of benefits to veterans.

It was agreed that the meeting was not to be seen as having been arranged by any particular organisation but by individual veterans.

The meeting was a great success, with over two thousand people attending; also it received plenty of media coverage.

AUSTRALIAN NATIONAL UNIVERSITY

ADOUT

This conference of which I spoke on Saturday, was a great success. I was included on the organising committee but it was basically organised by scientists from ANU who were concerned by the way Justice Evatt treated scientific evidence.

SUBMISSIONS

The National Office has been involved in producing four submissions relating to the Monitoring Committee Report.

THE FUTURE

- The Association must maintain the political pressure on the government for their acceptance of the recommendations contained in the "After the March" report.
- 2. There are now four cases that have been won at the Veterans Review Board relating to chemical exposure and cancer. There are three cases at the AAT and a number either ready to be heard by the VRB, or at the stage of preparation to be listed for hearing. The VVAA must maintain a high profile in this area.

- 3. Since the study of Field and Kerr has been released and the change of mind by the scientist conducting the "Ranch Hand" Study, the VVAA must maintain political pressure to have the children that suffer from birth defects be made eligible for benefits under the Veteran Entitlement Act.
- 4. VVAA must look at the training of advocates to the Veterans Review Board. This may be done by running courses.
- 5. A watch must be kept on the Department of Veterans Affairs relating to any move which would interfere with the independence of the Veterans Review Board.
- 6. Establishment of half way houses in every state.

In conclusion I have been involved with the VVAA since 1981. There are a number of items that I wish to see completed so I have decided to seek re-election for National President and I believe that my qualifications for my re-election are:-

- Involvement with the issues for eight years
- Because of this involvement I now have a vast contact within the scientific community. This has been further broadened since the Evatt Revisited Conference. (John Pollock George Humphries, Ben Selinger, Red Steele, Peter McCullagh, Prof Axleson, Prof Hardell etc.)

Over the years I have established a network of lawyers who are willing to work for us, free of charge (Bob Wyburn, Alun Hill, Steve Crawshaw, Adrian McInness etc).

My involvement with the National Advisory Council which advises the Minister on matters relating to the VVCS have given me a broad knowledge of the operation of the counselling services.

I have a good relationship with the Minister for Veteran's Affairs in spite of policy differences. I also have a good relationship with Tim Fishcher MHR, Senator Paul McLean who are both the shadow spokesmen on Veteran's Affairs for their parties.

I have a good relationship with many back benchers including the National Secretary of ALP Bob Hogg (who is presently seeking an appointment for us to see the Prime Minister.)

My knowledge of the chemical issue which I am now putting to use at the $\ensuremath{\text{VRB}}$.

- I am a TPI pensioner and I have the time to work on a full time basis. Also, I believe the President of the Association should be based in a major city.
- I have established a good relationship with many sections of the press.
